**Section 1. Short Title**

This bill may be titled as, “Recommendation of the 2022-2023 USG Senate Committees”

**Section 2. Discussion**

**Whereas**, This bill is to signify the recommendation from the Office Administration Committee for Senate Committees for the 2022-2023 term. The Office Administration Committee was composed of the President-elect, Vice President-elect, and newly selected Cabinet Director. The OAC conducted a “2022-2023 Committee Preferences” form for senators to select their committee preferences. Each Senator shall serve two total committees, one from each BLOCK of committees.

**Whereas,** The Justice & Equity Committee, Governmental Relations Committee, Finance, and Student Life Committee are all in BLOCK 1.
