An Act

To assign standing committee placements to the senate nominees of the fall 2022 cycle.

Section 1. Short Title

This legislation may be cited as “Committee Placement of the Fall 2022 Senate Nominees”

Section 2. Discussion

Whereas, the Internal Affairs committee, through a blinded application process, nominated 14 senate applicants to the Senate of USG.

Whereas, the USG bylaws detail nine (9) standing committees to exist as subsets of the legislative branch of USG.

Whereas, the aforementioned committees are assembled as follows:

- Academic Affairs
- External Affairs
- Finance
- Governmental Relations
- Health & Safety
- Internal Affairs
- Justice & Equity
- Student Life
- Sustainability

Whereas, per the USG bylaws, each senator is required to serve on two (2) standing committees to fulfill the requirements set forth in description of their position.

Whereas, the Finance and Internal Affairs committees were not accepting new members at the time that the Speaker and Speaker Pro Tempore placed fall 2022 nominees on their respective committees.

Whereas, per the USG bylaws, the Speaker and Speaker Pro Temp conducted a placement session in which each senator was assigned to two (2) committees based on their individual preferences.
